Location

Jarvey Street is located within the town centre of Bathgate, in West Lothian, a region which has a residential population of 150,000.

Bathgate is easily accessible, as it enjoys excellent communication links to the M8 Motorway via Junction 3A and 4, which connect with Glasgow, Edinburgh and the rest of the Scottish motorway network. Glasgow and Edinburgh International airports are within easy reach.

Half hourly rail services connect the town to Edinburgh Haymarket and Waverley Station. In addition, a regular train service now connects Glasgow City Centre to the town.

Description

The subjects are located in close proximity to the junction with Hopetoun Street and Main Street within Bathgate town centre.

The property is formed over ground and first, with a large basement storage area.

Internally, the property provides mainly open plan space allowing for space planning flexibility.

On the first floor, the property benefits from a toilet and small tea preparation facility.
